I may not utilize the Vatican Archival Materials for editorial and/or professional purposes, including printed publications, (books, reviews and newspapers), electronic publications (CDs, DVDs, e-books, Internet, etc.), temporary exhibitions to the public, audio-visual media (videos, documentaries).
- 7. I understand that the Museum (including Museum employees, contractors, and other agents) do not have the authority grant permission for me to use the Vatican Archival Material in a manner inconsistent with the restrictions contained herein.
- 8. If I wish to use the Vatican Archival Materials for purposes not permitted herein, I must first seek permission from and obtain the written consent of the VAA. Requests should be directed to archivio@aav.va.
- 9. I further understand that if I wish to obtain scanned copies of individual documents, I must contact the VAA by filling out an online order form titled "Photo reproduction Order Form for Private Study Use" available at https://servizi.archivioapostolicovaticano.va/fotoriproduzioni/#/?lang=it. I understand that I must obtain the consent of the VAA for any reproduction, publication, commercial and/or non-commercial use of the requested duplicate scans. This includes editorial and/or professional purposes, including printed publications (books, reviews and newspapers), electronic publications (CDs, DVDs, e-books, Internet, etc.), temporary exhibitions to the public, audio-visual media (videos, documentaries). Such use might be subject to a separate agreement or license of use between myself and the VAA, as determined by the VAA.
